


REMEMBERING Martin Luther King Jr.

Professor Harry Waters Jr. to preach Martin Luther King Jr. sermon at Augustana

On Sunday, January 19, come and hear an excerpt of one of Rev. Dr. Martin Luther King Jr.'s sermons preached at both worship services by Professor Harry Waters Jr. Professor Waters will also lead a discussion about Rev. Dr. King's speeches and sermons and what they teach us in Adult Forum, 9:15–10:15 a.m., in the Anna Paulson Room.

Professor Harry Waters Jr. teaches in the Theater and Dance Department of Macalester College, and he is also the Associate Dean of the Kofi Annan Institute for Global Citizenship. A relevant aside, his parents, Harry and Betty Waters, are Augustana members. He portrayed Marvin Berry in the movie



Back to the Future which earned him a Gold Record for his rendition of "Earth Angel," guest-starred in many television roles, worked as an actor on and off Broadway, and directed productions in the Twin Cities, and nationally, and at Macalester College. Mr. Waters received his MFA in Directing from the University of Wisconsin-Madison, and holds a Meisner Acting Technique Teacher Certification with Larry Silverberg.

O Lord, you have searched me and known me. You know when I sit down and when I rise up; you discern my thoughts from far away. You search out my path . . . and are acquainted with all my ways.

Psalm 139:1-3

I remember reading this psalm many years ago with a family whose child had suddenly died. I was a young summer chaplain at University Hospital, and they asked to have a service in the chapel together.

Summer chaplaincies (which most pastors and deacons complete as part of their education) have a way of disabusing you of the notion that you can fix everything. They also have a way of cracking open your heart so you can share all the sorrow, fear and wonder that are a part of being alive.

I don't remember much detail of that particular memorial service. I do remember that the promise of God's constant presence in their child's life brought the family comfort in the midst of their grief. And I do know that I have returned to this psalm again and again over the years for comfort, peace and hope.

When we stand on the edge of a new year, it's often a time of reflection on the past and straining forward to try to see the future that's ahead. It's a wonderful time to remind ourselves that no matter

what has happened or will happen, we are embraced and known each day by God's love in Christ. As our own baptismal liturgy says: "Child of God, you have been sealed by the Holy Spirit and marked with the cross of Christ forever."

How will we let that promise shape our 2020?

The Good Reverend

Reverend Doctor Martin Luther King Jr. is often quoted in pithy bits of larger works. Constrained by necessarily brief memes and tweets, so much of what he had to say never reaches our

ears much less our hearts. Sunday, January 19, we'll have the opportunity to hear one of Rev. King's sermons preached by Professor Harry Waters Jr. at both worship services. More than theatrical presentation, Professor Waters gives us an opportunity to listen well to a powerful message from Rev. King from our pulpit. White folks can listen and pause to wonder how often it is that we're in a moment of deep listening to people of color who are also siblings in the faith.

As a descendent of slave owners, I find this kind of listening a powerful reversal to the bulk of our country's dark and painful racial history as well as the present time. It moves us beyond lip service to reconciliation and opens the possibility of moving us one step closer to it. The apostle Paul has a thing or two to say about reconciliation:

So if anyone is in Christ, there is a new creation: everything old has passed away; see, everything has become new! All this is from God, who reconciled us to

himself through Christ, and has given us the ministry of reconciliation.

2 Corinthians 5:17-18

We're set free in Christ to turn towards our neighbor and wonder what's possible by way of reconciliation. Sometimes our wondering takes place in a low risk setting like our own worship space. Come and listen. Who knows what might become possible?


If you are also setting resolutions or goals for yourself and your family, look at what is important to you, write it down (it is much more likely to be achieved), and make the commitment.

Constitution Amendments to be voted upon in February

These constitution amendments have been approved at the August ELCA Churchwide Assembly and at the Augustana November Congregation Council and will be voted upon at the February congregation meeting. To see the full text of amendments go to www.elca.org then go to churchwide organization, then to Office of the Secretary, then to constitutions, then to 2019 Amendments to Model Constitution for Congregations.

Remember that paragraphs with an * (i.e., *C5.04) are required changes.

Summary of Amendments to the Model Constitution for Congregations, 2019

Additions are **underlined**. Deletions are **struck through** in the text.

Most changes:

- Replace "synodical" with "synod"
- Replace "the congregation" with "this congregation"
- Editorial changes so that the *Model Constitution for Congregations* follows the *Constitution, Bylaws, and Continuing Resolutions of the Evangelical Lutheran Church in America* and the *Constitution for Synods*.
- Some renumbering of paragraphs as needed
- Some word changes, such as "~~effected taken~~", "~~disabled with disability status~~", "~~partnership with support of~~", "~~partnership collaboration~~", "~~benevolence mission support~~".

*C5.04. This congregation shall **choose elect** from its voting members laypersons to serve as voting members of the Synod Assembly...

*C6.04. Affiliation with the Evangelical Lutheran Church in America **may be is** terminated as follows:
c. This congregation is removed from membership in the Evangelical Lutheran Church in America **...or in accordance with provision 9.23. of the constitution and bylaws of the Evangelical Lutheran Church in America.**
d. **The Rocky Mountain Synod takes charge and control of the property of this congregation to hold, manage, and convey the same on behalf of the synod pursuant to ¶S13.24. of the synod constitution. This congregation shall have the right to appeal the decision to the next Synod Assembly.**

*C6.05. This congregation may terminate its relationship with the Evangelical Lutheran Church in America by the following procedure:
(a. through h. details the process of termination. The main change in these paragraphs is to now require **two** legally called and conducted special meetings, and outlines steps for each meeting.)

*C7.01-.05 Property Ownership
.02 If this congregation is removed from membership in the Evangelical Lutheran Church in America...**or pursuant to 9.23. of the constitution and bylaws of the Evangelical Lutheran Church in America.**
.03 and .04 removes "two-thirds" requirement for votes of voting members of this congregation to leave Evangelical Lutheran Church in America.
.04 line 9 ...**in neither case does title to this congregation's property transfer to the synod.**

*C7.05. (This provision becomes required; it previously was optional. If the congregation leaving the synod has received property from the synod, the congregation must return the property to the synod.)

Election results

At Augustana's congregational meeting November 10, **Roger Lipker** and **Pam Uyemura** were elected to the 2020 Congregation Council. **Grace Blanchard** was elected as the youth representative and **Ogden Willoughby**, as the alternate.

Emmett Cruson, **Margaret Aarestad**, **Anne Stratton**, and **Brian Willoughby** were elected to the 2020 Nominating Committee.

Morgan Levy and **Nick and Holly Massie** were elected as voting members to the 2020 Synod Assembly.

*C8.02. Membership

c. **Voting** members...line 6 They shall not have voted as a seasonal member of another congregation of this church in the previous two calendar months.

*C8.05. Membership in this congregation shall be terminated by any of the following:

d. disciplinary action in accordance with ELCA constitutional provision 20.41. and the accompanying bylaws Chapter 20 of the constitution and bylaws of the Evangelical Lutheran Church in America;

*C9.03. a. Every minister of Word and Sacrament shall:

6) impart knowledge of this church and its wider ministry through distribution of its communications and publications available channels of effective communication:

b. Each pastor...shall...

6) encourage adherence to covenantal relationship with this church as expressed in the Constitution, Bylaws, and Continuing Resolutions of the Evangelical Lutheran Church in America.

*C9.14. line 5 ...before the installation of that pastor in another field of labor or the granting by the synod of retired status to the pastor call or approval of a request for change in roster status.

*C9.21. Authority to call a minister of Word and Service deacon...

*C9.26 The deacon shall make satisfactory settlement of all financial obligations to a former congregation before:

a. installation in another field of labor, or

b. the issuance of a certificate of dismissal or transfer.

This congregation shall make satisfactory settlement of all financial obligations to a former deacon before calling a successor. A deacon shall make satisfactory settlement of all financial obligations to this congregation before beginning service in a call to another congregation or employment in another ministry setting.

Changes in C10 through C13

C10.01. The [annual] meeting of this congregation shall be held at a time specified in the bylaws. This congregation shall have at least one regular meeting per year. The regular meeting(s) of the congregation shall be held at the time(s) specified in the bylaws. Consistent with the laws of the State of Colorado, the bylaws shall designate one regular meeting per year as the annual meeting of this congregation.

C10.08. This congregation may hold meetings by remote communication, including electronically and by telephone conference, as long as there is an opportunity for simultaneous aural communication. To the extent permitted by state law, notice of all meetings may be provided electronically.

C12.01. and C12.02. allow the addition of the deacon to the voting membership of the Congregation Council.

C12.02. line 5. Newly elected Congregation Council members shall be installed at worship the Sunday prior to the date they assume office at a time appointed by the Congregation Council.

C13.05. When a pastoral vacancy occurs in a position for which this congregation calls a rostered minister, a Call Committee... Term of office will terminate upon installation of the newly called pastor rostered minister.

*C15.11. When there is disagreement among factions within this congregation on a substantive issue that cannot be resolved by the parties, members of this congregation shall have access to the synodical bishop for consultation after informing the chair of the Congregation Council of their intent. If the consultation fails to resolve the issue(s), the Consultation Committee of the synod shall consider the matter. If the Consultation Committee of the synod shall fail to resolve the issue(s), the matter shall be referred to the Synod Council, whose decision shall be final.

When there is disagreement between or among factions within this congregation of a substantive issue which cannot be resolved by the parties, members of this congregation may petition the synod bishop for consultation after informing the president of this congregation of their intent to do so. The synod bishop shall seek a timely resolution of the dispute. If the issue relates directly to the pastor, the bishop may begin the process in ¶S14.18.d. In all other matters, if the bishop's consultation fails to resolve the issue, the bishop shall refer the matter to the Consultation Committee of the synod, which shall undertake efforts to find an appropriate solution. If the Consultation Committee's efforts fail to resolve the dispute, the entire matter shall be referred to the Synod Council for adjudication by whatever process the Council deems necessary. The Synod Council's decision shall be final.

*C16.02 amendments: change approved and ratified from Congregation Meeting to any regular meeting of the congregation.

*C17.04 and *C18.03 Adopted or amended bylaws and continuing resolutions shall be sent by the secretary of this congregation to the synod.

Proposed Bylaw Amendments to be voted upon in February

These bylaw amendments, presented by the Augustana Foundation Board, were approved at the Augustana November Congregation Council meeting. They will be voted upon at the February congregation meeting. Additions are underlined. Deletions are ~~struck through~~ in the text.

3) Officers of this congregation shall hold the same offices on the Congregation Council, such officers being the president, vice-president, secretary, and treasurer.

d. Treasurer:

....Each year the treasurer shall submit to the Congregation Council and to this congregation an audit of all financial records and transactions to include those of the Augustana Foundation ~~Fund~~ Board along with the annual financial report. ...

10) The Augustana Foundation ~~Fund~~ Board, created by and responsible to the congregation for management of those endowed and other funds transmitted to its care, shall through its Treasurer cause an annual report ~~and outside audit of its transactions~~ to be submitted to the Congregation Council as part of its annual report to the congregation. The transactions of the Augustana Foundation Board shall be included in the congregation's outside audit. ...Expenditure guidelines issued by the congregation to ~~The the Augustana Foundation Fund Committee Board~~ should be reviewed annually to assure Foundation responses to changing congregational objectives under changing internal and external circumstances, whether financial of or pastoral.

Challenge nets over 1,500 pounds!

Thank you to all who gave to the Chili Challenge for Metro Caring and George Washington High School food pantries. This sixth annual friendly competition between the congregation (920 pounds) and the Augustana Early Learning Center (635 pounds) combine for a total of 1,555 pounds! 250 cans were given to the high school along with 25 can openers that were needed during Finals Week for students in need and their families. Thank you for your generosity as we continue to hear from local neighbor organizations about how best to partner with them.

We have a team of Refugee Mentors!

On Sunday, December 1, five Augustana members were trained to be refugee mentors by **Mary Feeney Francis** of Lutheran Family Services. Two more have signed up for training later. We learned about an alphabet soup of categories of immigrants and what it means to be a refugee.

Mary pointed us to tools that will be helpful to us and gave us scenarios simulating situations we may encounter as refugee mentors and advice about what to do. We are excited to finish our applications, pass our background checks and be matched with a family. The whole team will then

meet with the family for introductions.



Dare to Love More

DLM Food and Resources at Holy Trinity Lutheran Church in Akron, Ohio, is a place where families find nourishing food, warm clothes and an equally warm welcome.

“At first glance, it’s not much different from any well-run, client-choice food pantry,” said Deacon Marla Wood Kay, director of congregational ministries at Holy Trinity.



But, Wood Kay said, “the idea for this ministry was born in a hospice room,” where Holy Trinity member Debra Manteghi was dying of cancer.

For years, Manteghi had advocated for families. She developed Project RISE (Realizing Individual Strength through Education), a federally funded program

connecting Akron Public Schools, shelters and community organizations to support students who are homeless.

After her death, need and opportunity converged.

“I had a desire to continue Debra’s ministry,” Wood Kay said. “Project RISE needed a food pantry to direct their families to.”

In June 2017, Holy Trinity approved the food pantry ministry. Donations in Manteghi’s honor and a church endowment supported it.

When it was time to name the new ministry, Manteghi’s son, Amir, and his fiancée, Monica Band, named it DLM, which stands for “Dare to Love More” and also “Debra Lynn Manteghi.”

Since opening to guests in October 2017, DLM has grown, serving 75 families—300 people—on average per month. Wood Kay said DLM picks up 1,500 to 3,500 pounds of food three times per month and is a member of the Akron-Canton Regional Foodbank,

which provides food and other essential items to area hunger ministries.

While their parents shop, children read books and play games that were collected by Holy Trinity. Plans are underway to expand offerings beyond food, including more adult and children’s clothing, school uniforms and drop-in counseling.

Volunteers, along with an ELCA World Hunger Domestic Hunger Grant, help DLM thrive.

Thanks to your gifts to ELCA World Hunger, the ministry has been able to increase refrigeration capabilities and purchase extra food.

“Our clients feel seen, heard and loved,” said Rachel Breece, Project RISE special programs coordinator.


